Situated in the Village Of Frazeyburg, Muskingum County, Ohio. Being part of the Northeast Quarter of Section #19 as conveyed to the Methodist Church in Deed Books X page 331, 815 page 186 and 817 page 236 of the Muskingum County Deed records and being described as follows:

Commencing at the Northeast corner of lot #13 of Issac Franks addition as recorded in Plat Book 1 page 217; thence, S.89°50'00"E. a distance of 117.15 feet along the South line of Second Street to a set iron pin, **BEING THE POINT OF BEGINNING;**

thence, S.89°50'00"E. a distance of 133.79 feet along the South line of Second Street to a set iron pin, on the West line of Basin Street;

thence, S.00°10'00"W. a distance of 77.00 feet along said Basin Street to a set iron pin;

thence, N.89°50'00"W. a distance of 133.79 feet through the lands of the Methodist Church to a set iron pin;

thence, N.00°10'00"E. a distance of 77.00 feet through said Church lands to the point of beginning.

The above described parcel contains 0.236 acres, more or less, and is subject to all legal easements and right of ways. All set iron pins are 5/8" x 30" rebars with I.D. caps. North is based an assumed meridian.




