**SURVEY DESCRIPTION

ALL OF AUDITORS PARCEL
29-61-24-13-000 (0.24 Acres)

Situated in Lots 62, 64, and 65 of the Town Plat of Frazzeysburg (formerly Knoxville), Village of Frazzeysburg, Muskingum County, Ohio.

Beginning at the Southwest corner of lot 64 of the Town plat of Frazzeysburg (Formerly Knoxville) recorded in Plat Book 1, Page 250 of the Muskingum County Plat records;

Thence, **N.00°00'00"E.** a distance of **42.65 feet** along the West line of lot 64, and the East line of Basin Street to a point on the Southwest corner of the lands, now or formerly, owned by J. & N. Luther (1027/163);

Thence, **N.90°00'00"E.** a distance of **191.00 feet** through lots 64 and 62, and along the south line of said Luther lands and the lands, now or formerly, owned by L. Fadley (1896/803), passing a found iron pin at 0.45' and passing the East line of lot 64, also being the Southwest corner of said Fadley lands, at 165.00', to a set rebar on the Western line of North Canal Street;

Thence, **S.42°14'38"W.** a distance of **38.67 feet** along said street to a point on the Southwest corner of Lot 62;

Thence, **S.45°39'59"W.** a distance of **20.06 feet** along said street to a point on the Southeast corner of Lot 64;

Thence, **S.38°48'19"W.** a distance of **30.16 feet** along said street to a point on the Northeast corner of the lands, now or formerly, owned by G. & D. Peterson (1062/611), referenced by a set rebar bearing **N.90°00'00"E.** a distance of 25.00 feet;


Thence, **N.90°00'00"W.** a distance of **131.75 feet** along said Peterson lands and through Lot 65 to a set rebar on East line of Basin Street;

thence, **N.00°00'00"E.** a distance of **23.50 feet** along the East line of Basin Street to the point of beginning.

The above described parcel contains 0.24 Acres, more or less, subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

 COUNTY, OHIO.




