Situated in the Village of Frazeyburg, Muskingum County, Ohio. Being part of the lands of C. & S. Harlan as conveyed in Deed Book 887 page 157 of the Muskingum County deed records and being described as follows:

Beginning at an iron pin set on the Southeast corner of lot 43 of the Town Plat of Frazeyburg (formerly Knoxville, P.B. I, Pg. 250);

thence, N.00°10'00"E. a distance of 165.00 feet along the East line of a lot 43 to a set rebar on the Northeast corner of said lot;

thence, S.03°19'57"E. a distance of 106.53 feet through lot 44 to a set rebar;

thence, S.01°10'28"W. a distance of 58.66 feet through said lot to a set rebar on the North line of a 16.5 foot wide alley;

thence, N.90°00'00"W. a distance of 5.47 feet along said alley to the point of beginning.

The above described parcel contains 0.016 acres, more or less, and is subject to all legal easements and right of ways. North is based an assumed meridian. All set rebars are 5/8"x 30" rebars.




