

Re-Survey of Lila Lee Robison Lands in Frazeytsburg ,Ohio

Parcel 1

Situated in the State of Ohio, County of Muskingum, Township of Jackson, Village of Frazeytsburg, and being part of the Southeast Quarter of Section 19, Township 3, Range 9, United States Military Lands, and being all the lands presently owned by Lila Lee Robison as per Official Record 2767-767, Parcel 1, and being more particularly described as follows:

Beginning for reference at an iron pin found at the Southeast corner of Lot 58, of the Plat of Knoxville, (Deed Bk. I, Pg. 250), Village of Frazeytsburg;

Thence along the north line of Canal Street, North 87 degrees 52 minutes 50 seconds West, 304.13 feet to an iron pin found;

Thence across said street, South 35 degrees 06 minutes 02 seconds West, 205.80 feet to a point on the east line of said street, and the southwest corner of lands presently owned by Angela M. Roberts,(DR 1130-489), and the principal place of beginning;

Thence along the south line of said Roberts lands, South 39 degrees 57 minutes 41 seconds East, 166.00 feet to and axle found on the west line of lands presently owned by Myron Jeffrey Smith, (OR 2656-84), passing an iron pipe found at 5.93 feet;

Thence along the west line of said Smith lands, South 42 degrees 29 minutes 05 seconds West, 104.97 feet to an iron pin set;

Thence along the line between Parcel 1, and Parcel 2, of said Robison lands, North 46 degrees 51 minutes 58 seconds West, 164.97 feet to an iron pin set on the east line of Canal Street;

Thence along the east line of said street, North 42 degrees 39 minutes 58 seconds East, 124.92 feet to the principal place of beginning, containing 0.435 acres, more or less, and being all of Auditor's Parcel Number 29-62-03-05-000.

Parcel 2
