Situated in the Village of Frazeyburg and in the Southeast Quarter of Section 19, T-3-N, R-9-W, U.S.M.L., Jackson Township, Muskingum County, Ohio. Being part of the lands of the Raymond H. Frew, Jr. and Brenda K. Frew Revocable Living Trust recorded in Deed Book 1902 page 93 of the Muskingum County Deed records and being described as follows:

Beginning at a point located at the intersection of the South line of the Village of Frazeyburg with the west line of the Southeast quarter of section 19, said point referenced by a found concrete post located S.89°40'08"W. a distance of 1.44 feet;

Thence, **N.00°09'46"W.** a distance of **1,250.99** feet along the West line of said Quarter section line to a found iron pin on the South line of a rail road owned by Caprail;

Thence, **N.65°02'48"E.** a distance of **121.15** feet along the South line of said rail road to a set rebar;

Thence, **S.89°58'03"E.** a distance of **667.23** feet along the South line of the lands, now or formerly, owned by R. & R. Priest (818/302) to a set rebar;

Thence, **S.00°24'00"W.** a distance of **978.59** feet through the lands of the Raymond H. Frew, Jr and Brenda K. Frew Revocable living Trust (1902/093) to a point on the old South line of the Old Ohio Canal, located in the road bed of Canal road, passing a set rebar at 932.17 feet;

Thence, **S.39°39'21"W.** a distance of **415.89** feet along said canal lands and with Canal road to a point on the South line of the Village of Frazeyburg;

Thence, **S.39°39'21"W.** a distance of **362.67** feet along said canal lands and with Canal road and along the lands of I. Vickers (679/046) to a point;

Thence, **S.42°17'06"W.** a distance of **398.63** feet along said canal lands and with Canal road and along the lands of I. Vickers (679/046) to a found iron pin on the West line of the Southeast quarter of Section 19;

Thence, **N.00°09'46"W.** a distance of **571.16** feet along said quarter section line to the point of beginning.

The above described parcel contains 25.33 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

SURVEY PLAT FOR THE JACKSON TOWNSHIP TRUSTEES




