The parcel herein described is known as being part of the same lands conveyed to **Thomas Curtis Heisey, Trustee of the George D. Heisey Trust of August 22, 1993** as described in Deed Volume 2004 on Page 429 recorded in the Muskingum County Recorder's Office in Zanesville, OH. The parcel is situated in and part of Section 25 in the Third Quarter of Jackson Township, Township 3 North in Range 9 West in the U.S. Military Lands of Muskingum County, Ohio and is better described as follows:

Beginning for a reference at a point in the center of Marne Road (Old State Route 16) at Centerline Station 161+44.72 (MUS - 16 - 0.00, dated 1931) referenced by an existing 5/8" iron pin bearing North 75 degrees 13 minutes 41 seconds West, 32.73 feet therefrom;

Thence, with the center of the said road, South 37 degrees 19 minutes 57 seconds West, 398.41 feet to a point at Centerline Station 157+46.31 (MUS -16-0.00, dated 1931);

North is based on the center line of Marne Road as bearing South 37 degrees 19 minutes 57 seconds West. The bearings, used in this description, show the relationship of the angles of the property lines and are not based on true bearings. The iron pins set are 5/8" x 30" Re-bar with a plastic ID cap stamped "Boeshart S-6512".
