

1.02 Acre Split of Jerald L. and Donna Frazier Lands

Beginning for reference,(by deed), at an iron pin at the Southeast corner of Section 21, Township 3, Range 9, United States Military Lands;

Thence along the south line of lands presently owned by George T. and Janet L. Moses,(OR 1532-341), (by deed), South 87 degrees 29 minutes 48 seconds East, 701.81 feet to a point in the centerline of Shannon Road,(Co. Rd. 48), passing an iron pin at 671.59 feet;

Thence along the centerline of said road, North 05 degrees 13 minutes 09 seconds West, 434.64 feet to a point on the northeast corner of said Moses lands;

Thence continuing along the centerline of said road, North 05 degrees 05 minutes 25 seconds West, 131.27 feet to a point, and the principal place of beginning;

Thence continuing along the centerline of said road, North 05 degrees 26 minutes 38 seconds West, 103.09 feet to a point;

Thence through the lands presently owned by Jerald L. and Donna Frazier,(OR 1883-239), the following seven courses:

- 5.) North 68 degrees 15 minutes 34 seconds West, 49.33 feet to an iron pin set;
- 6.) North 35 degrees 33 minutes 00 seconds West, 203.45 feet to an iron pin set;
- 7.) South 84 degrees 35 minutes 53 seconds West, 26.01 feet to the principal place of beginning, containing 1.02 acres more or less;


