Being part of the lands of Carolyn Green conveyed in Deed Book 1109 page 428 of the Muskingum County Deed Records and being described as follows:

Beginning at a found iron pin marking the Southeast corner of Lot 1, Quarter Township 1, Licking Township;

Thence, **S.89°51'31"W.** a distance of **528.01** feet along the South line of Lot 1 to a set rebar;

Thence, **N.00°08'00"E.** a distance of **764.96** feet through the lands of C. Green (1109/428) to a set rebar;

Thence, **N.89°51'31"E.** a distance of **824.62** feet through the lands of C. Green to a found iron pin on the Northwest corner of the lands of E. Lawler (1109/440);

Thence, **S.35°52'37"W.** a distance of **458.09** feet along said Lawler lands to A found rebar;

Thence, **S.27°09'29"E.** a distance of **449.87** feet along said Lawler lands to A found rebar on the North line of the lands of C. Jordan (951/243);

Thence, **S.76°14'48"W.** a distance of **242.37** feet along said Jordan lands to A found rebar on the Muskingum/Licking Township line;

Thence, **N.00°08'00"E.** a distance of **63.38** feet along said Township line to the point of beginning.



Situated in Section 5, T-2-N, R-8-W, Muskingum Township, Muskingum County, Ohio. Being a 40.00 foot wide easement for ingress, egress and utility use across the south side of the lands of Eric Lawler lands described in Deed Book 1109 Page 440 of the Muskingum County Deed Records whose centerline is described as follows:

Commencing at the Southeast corner of ~~Section 5~~<sup>lot 1</sup> of ~~Muskingum~~<sup>Licking</sup> Township, located on the West line of Muskingum Township; Thence, S.00°08'00"W. a distance of 63.38 along said Muskingum Township line to a found iron pin on the Northwest corner of the lands of C. Jordan (951/243); Thence, N.76°14'48"E. a distance of 242.37 along said Jordan lands to a found iron pin on the South West corner of the lands of E. Lawler (1109/440); Thence, N.27°09'29"W. a distance of 20.56 along the West line of said Lawler lands to a point, BEING THE POINT OF BEGINNING;

Thence, **N.76°14'48"E.** a distance of **728.51** feet through the lands of E. Lawler and along the center line of the 40 foot wide easement to a point in the center of County Road 48 (Shannon Road);

All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.
