Situated in the Village of Dresden, Muskingum County, Ohio. Being the South half of Lot #4 of the Joseph Adams Addition as recorded in Deed Book 10 page 78 of the Muskingum County deed records and being described as follows:

Beginning at an axle found in the Northeast corner of lot #5 of Joseph Adams Addition (D.B. 10 Pg. 78);

thence, S.65°00'00"W. a distance of 140.25 feet along the North line of said lot to a found 3/4" pipe on the East line of Clay Street;

thence, N.25°00'00"W. a distance of 30.27 feet along said Street to a set iron pipe;

thence, N.65°00'00"E. a distance of 140.25 feet through lot #4 to a set iron pipe on the west line of a Public Alley;

thence, S.25°00'00"E. a distance of 30.27 feet along said alley to the point of beginning.

The above described parcel contains 0.097 acres, more or less, and is subject to all legal easements and right of ways. All set iron pipes are 3/4" x 30" pipes with plastic I.D. caps. North is based upon an assumed meridian. Description was prepared from an actual survey by Bowman & Associates, Stephen M. Bowman, P.S.#7135. July 30, 1994.



**SURVEY PLAT FOR DANETTE PRINCE**


