Situated in lot 5 of Compton's Subdivision of quarter township 1, T-2, R-9, Licking Township, Muskingum County, Ohio. Being parcel 3 of the lands of Harold and Carolyn Neldon, conveyed in Deed Book 469 page 134 of the Muskingum County deed records and being described as follows:

- Beginning at a set rebar in the Northwest corner of lot #5 of Compton's Sub.;
- Thence, S.88°48'25"E, a distance of 1,056.00 feet along the North line of said lot to a point, passing a set rebar at 1,041.32';
- Thence, S.00°03'29"E, a distance of 1,645.16 feet along the lands of W. Kilpatrick (1066/451) to a point;
- Thence, N.88°48'25"W, a distance of 1,056.00 feet along the South line of lot 5 to a wood post, passing a set rebar at 88.23';
- Thence, N.00°03'29"W, a distance of 1,645.16 feet along the West line of lot 5 to the point of beginning.

The above described parcel contains 39.873 acres, more or less, and is subject to all legal easements and right of ways. North is based upon an assumed meridian.


NORTH IS BASED UPON
