Description for Jane Mathy et.al

Being a part of lot 7, of Compton's Subdivision, Plat Book "D", Page 101, situated in the Northwest Quarter of Quarter Township 1, Township 2, North ; Range 9, West , Licking Township ,Muskingum County , State of Ohio , and being a tract last transferred to Jane Mathy and Judith Clay as recorded in deed book 1095 , page 263 of said county records and being further described as follows :

Beginning for reference at the Southwest corner of lot 7 of Compton 's Subdivision , Deed Book "D" , Page 101, thence N 86degrees 13 minutes 46 seconds East 1336.5 feet by deed, to an iron pin found at the southwest corner of a tract owned by Albert McGinnis et. al [Deed book 1087 , page 189], thence along the west line of said tract N 03 degrees 46 minutes 14 seconds West 2605.18 feet to an iron pin set ,said iron pin being the place of beginning for the tract herein described . Thence North 03 degrees 46 minutes 14 seconds West 16.5 feet to a stone found with an "X" inscribed on the top , thence North 85 degrees 42 minutes 35 seconds East 288.97 feet to a railroad spike set in the center of Lentz road [Township road 120] , thence along said centerline South 35 degrees 26 minutes 11 seconds East 19.28 feet to a railroad spike set , thence South 85 degrees 42 minutes 35 seconds West 299.09 feet to the place of beginning , containing 0.1114 of an acre, more or less . Said tract subject to all right of ways and easements either written or implied . Bearings are based on a previous survey by W.H. Derwacter and are for angular calculation only. All iron pins set are 5/8 inch by 30 inch rebar with LD. caps stamped Walton S-7675. Description prepared by Steven B. Walton , Ohio Professional Surveyor S-7675 on the 3rd day of July , 1996 .




