Commencing at a stone found at the southeast corner of said Lot 8; thence N 2° 11' 43" E (the base of bearings for this description is true north by an observation of the sun) along the east line of said Lot 8 a distance 1945.81 feet to an iron pin found; thence S 68° 05' 22" W along the southerly side of Hunt Road 305.84 feet to an iron pin set at the true place of beginning for the following described parcel; thence continuing S 68° 05' 22" W along the southerly side of said Hunt Road and the north line of a 16.252 acre parcel owned by Judith Elekes (Vol. 1006, pg. 477) a distance of 587.36 feet to an iron pin set in a 1996 survey at the southeast corner of a 1.475 acre parcel owned by Ray and Beth Stull (Vol. 1128, pg. 928); thence following the lines of said Stull property and said 1996 survey the following 2 courses and distances:
1 - N 27° 32' 19" W 114.42 feet to an iron pin set and passing through an iron pin set at 30.00 feet

2 - S 81° 47' 05" W 447.18 feet to an iron pin set on the northerly line of property owned by James Gause (Vol. 1006, pg. 491); thence N 57° 02' 23" W along the north line of said James Gause property 991.35 feet to an iron pin found on the east line of property owned by Keith Gause (Vol. 1000, pg. 108); thence N 1° 08' 14" E along the east line of said Gause property 101.00 feet to an iron pin found; thence S 85° 15' 18" E along the south line of a second parcel owned by said Keith Gause (Vol. 1006, pg. 485) a distance of 1888.28 feet to an iron pin set at the northwest corner of a 1.50 acre parcel to be sold to Kevin and Teresa Slaughter; thence S 2° 11' 43" W along the west line of said 1.50 acre parcel 302.74 feet to the true place of beginning and passing through an iron pin set at 268.04 feet containing Seventeen and Eight-hundred-thirty-six-thousandths (17.836).


