DEED OF CORRECTION FOR
(HEART OF OHIO FIRL SCOUT COUNCIL INC.)
TO
LUTHUR C. HOTHEN

Situated in the Township of Madison, County of Muskingum, and State of Ohio, and being 122.762 acres more or less in the first quarter of Township #3 north, Range #7 west of the United States Military District, and being more particularly described as follows:

Commeicnig at at an iron pipe found at the northwest corner of said first quarter, thence with the north line of said quarter, S 83° 40' 30" E, a distance of 1601.18 feet to a stone found, thence leaving said north line, S 15° 56' 19" E, a distance of 8004.59 feet to a railroad spike set in the center of County Rd. #50, the BEGINNING, thence leaving said road N 16° 29' 04" W, a distance of 115.70 feet to a point on the south bank of the Muskingum River, (having passed through an iron pin set at 15.00 feet), thence with the south bank of the Muskingum River the next four (4) calls:

1. S 87° 51' 44" E, a distance of 236.44 feet to a point.
2. S 69° 28' 22" E, a distance of 262.47 feet to a point.
3. S 81° 35' 18" E, a distance of 145.19 feet to a point.

N 38° 14' 44" E, a distance of 191.11 feet to a point, thence S 31° 20' 29" E, a distance of 292.36 feet to an iron pin set on the west edge of Boy Scout Road, (having passed through an iron pin set at 15.00 feet), thence with the west line of Louis J. Kolb as described in volume 246, page 83 of the deed records of Muskingum County, Ohio the next four (4) calls:

1. S 08° 05' 29" E, a distance of 540.46 feet to an iron pin set.
2. S 21° 35' 27" E, a distance of 363.01 feet to an iron pin set.
3. S 05° 20' 29" E, a distance of 198.00 feet to an iron pin set.
4.
