

Adjoiner Split of Ronald J. and Dixie Lee Hooper Lands in Madison Township

Situated in the State of Ohio, County of Muskingum, Township of Madison, and being part of Quarter Township 2, Township 2, Range 7, United States Military Lands, and being part of the lands presently owned by Ronald J. and Dixie Lee Hooper, as per Deed Record 521, Page 53, and being more particularly described as follows:

Beginning for reference at the northeast corner of Quarter Township 2, Township 2, Range 7, United States Military Lands;

Thence along the Quarter Township line,(by deed), North 87 degrees 16 minutes 04 seconds West, 776.75 feet to an iron pin found on the northwest corner of lands presently owned by Henry Jason Vore, (OR 2335-589), and the principal place of beginning;

Thence along the west line of said Vore lands, South 00 degrees 56 minutes 06 seconds West, 138.63 feet to a point in the centerline of Mollies Rock Road, (Co. Rd. 40), passing an iron pin found at 97.70 feet;

Thence along the centerline of said road the following five courses:

- 1.) North 43 degrees 13 minutes 18 seconds West, 53.63 feet to a point;
- 2.) North 46 degrees 38 minutes 18 seconds West, 80.00 feet to a point;
- 3.) North 51 degrees 31 minutes 34 seconds West, 42.96 feet to a point;
- 4.) North 60 degrees 08 minutes 28 seconds West, 46.84 feet to a point;
- 5.) North 71 degrees 39 minutes 45 seconds West, 10.13 feet to a point on the south line of lands also presently owned by Ronald J. and Dixie Lee Hooper, (DR 521-53), and being the quarter township line;

Thence along the quarter township line and said Hooper lands, and the south line of lands presently owned by David F. Bice Trustees, (OR 2547-198), South 87 degrees 16 minutes 05 seconds East, 181.23 feet to the principal place of beginning, containing 0.25 acres, more or less, and being part of Auditor's Parcel Number 38-60-02-03-000.

Note: The above described parcel is not to be used as a separate building site, or transferred as an independent parcel in the future without planning commission approval in accordance with subdivision regulations.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5\8 inch rears , 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North, as per G.P.S. observations.




