SURVEY DESCRIPTION
FOR
HARRY SMITH

Situated in Quarter Township #2, T-2-N, R-7-W, U.S.M.L., Madison Township, Muskingum County, Ohio. Being part of the lands of Harry Smith as conveyed in Deed book 1049, page 477 of the Muskingum County Deed records and being more particularly described as follows:

Commencing at a concrete Monument located 30 feet left of station 10+53.31 of State Route #666 as recorded in Plat Book 14 Page 61 of the Muskingum County Plat Records; thence, N.80°48'06"E. a distance of 30.00 feet to a point in the center of said Route; thence, along the centerline of said State Route the following seven courses and distances, S.09°11'54"E. a distance of 56.63 feet to a point; thence, S.06°41'54"E. a distance of 147.84 feet to a point; thence, S.14°41'54"E. a distance of 136.33 feet to a point; thence, S.18°34'22"E. a distance of 696.21 feet to a point; thence, S.00°04'30"W. a distance of 396.45 feet to a point; thence, S.01°48'45"W. a distance of 1,041.40 feet to a point; thence, N.88°11'18"W. a distance of 20.00 feet leaving the centerline of said State Route to a set iron pin, BEING THE POINT OF BEGINNING; thence, S.01°48'45"W. a distance of 16.00 feet along the East line of H. Smith lands (1049/477) to a set iron pin; thence, N.88°11'11"W. a distance of 38.00 feet through said Smith lands to a set iron pin; thence, N.01°48'45"E. a distance of 18.00 feet through said Smith lands to a set iron pin on the South line of A. Minnich (777/297); thence, S.86°11'11"E. a distance of 38.00 feet along the South line of said Minnich lands to the point of beginning.

The above described parcel contains 608 Square Feet, more or less, and is subject to all legal easements and right of ways. North is based upon record bearings in deed book 939 page 232. All set iron pins are 3/4" x 30" pipes with I.D. caps.


