THENCE SOUTH 82° 54' 49" EAST 307.47' TO STATE ROUTE NO. 284 (REFERENCE: PASSING AN IRON PIN (FD) AT 268.78');

THENCE ALONG SAID STATE ROUTE NORTH 46° 14' 32" EAST 136.01' ;

THENCE LEAVING SAID STATE ROUTE SOUTH 43° 39' 28" EAST 153.90' TO THE POINT OF BEGINNING, CONTAINING 2.830 ACRES.

IRON PINS (SET) ARE 5/8" REBAR WITH I. D. CAPS (JANES 6029).


