- #1- THENCE South 86 degrees 56 minutes 34 seconds East 4725.39 feet along the common line for Sections 23 and 26 and through said Ohio Franklin Realty, LLC property to an unmarked point in the centerline of Coal Hill Road (Township Road 457), recorded in Plat Book 20, Page 125;
- **THENCE** with a curve to the left having, a chord bearing South 15 degrees 10 minutes 49 seconds East 41.05 feet, a radius of 675.14 feet, and arc length of 41.05 feet into Section 26, along said road, and continuing through said property to an unmarked point;
