

Re-Survey of Reformed Presbyterian Church Property

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, and being part of the north half of Fractional Section 3, Township 2, Range 8, United States Military Lands, and being all the lands presently owned by the Reformed Presbyterian Church by Deed Record DR 54-543, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at a stone found at the Northwest Corner of Lot No. 36, Quarter Township One, Township 2, Range 8, United States Military Lands;

Thence along the west line of said Lot No. 36, and lands presently owned by K. W. and K. S. Krebs(DR 1099-403), South 00 degrees 10 minutes 45 seconds West, 545.71 feet to an iron pin found on the east edge of Fulton Lane, being on the east line of lands presently owned by H. L. Gill(OR 1537-208), and passing iron pins found at 33.00 feet, and 518.49 feet;

Thence along the east line of said Gill lands the following two courses:

- 1.) North 32 degrees 11 minutes 40 seconds West, 396.00 feet to an iron pin set in the west edge of the traveled portion of Fulton Lane;
- 2.) North 21 degrees 11 minutes 40 seconds West, 227.70 feet to a point in Fulton Lane and the south line of lands presently owned by R. and J. Leas(DR 966-330), also being the north line of Fractional Section 3;

Thence along the south line of said Leas lands, and said fractional section line, South 89 degrees 40 minutes 11 seconds East, 295.02 feet to the principal place of beginning, passing an iron pin set at 15.00 feet, containing 2.05 acres more or less.

Subject to all legal easements and right of ways written or implied.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.

Bearings are based on the north line of Lot No. 36 as being South 89 degrees 48 minutes 12 seconds East, as per DR 1099-403.
