## Re-Survey of Jeffrey C. Jordan Lands in Muskingum Township

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, and being part of Section 4, Township 2, Range 8, United States Military Lands, and being all the lands presently owned by Jeffrey C. Jordan, as per Official Record 2832, Page 222, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at an iron pin found on the southwest corner of the Southeast Quarter of Section 4, Township 2, Range 8, United States Military Lands;

Thence along the mid-section line, and the east line of lands presently owned by William A. and Kristen J. Huston, (OR 2442-373), North 01 degrees 35 minutes 36 seconds East, 821.71 feet to point in a corner post, on the northeast corner of said Huston lands, passing an iron pin found at 816.71 feet;

Thence along the north line of said Huston lands, North 88 degrees 00 minutes 45 seconds West, 658.68 feet to an iron pin set on the southeast corner of lands presently owned by Farm Supply Center, Inc.(DR 948-26), passing an iron pin found at 5.00 feet;

Thence along the lines of said Farm Supply Center lands, the following five courses:

- 1.) North 02 degrees 18 minutes 29 seconds East, 1315.89 feet to a stone found;
- 2.) South 85 degrees 16 minutes 33 seconds East, 164.45 feet to a stone found, passing an iron pin set at 82.22 feet;
- 3.) North 02 degrees 02 minutes 41 seconds East, 955.44 feet to a corner post found, passing an iron pin set 229.64 feet, the centerline of Shannon Road, (Co. Rd. 48, R\W 40'), at 269.64 feet, and iron pins set at 309.64 feet an 945.44 feet;
- 4.) South 88 degrees 08 minutes 48 seconds East, 487.87 feet to an iron pin set;
- 5.) North 02 degrees 22 minutes 23 seconds East, 333.09 feet to an iron pin set on the southwest corner of lands presently owned by Adam L. and Tracey L. Herron, (OR 2869-273);

Thence along the south line of said Herron lands, South 87 degrees 59 minutes 39 seconds East, 1392.86 feet to an iron pin found on the west right of way of Frazeysburg Road, (St. Rte. 60), passing an iron pin found at 703.37 feet;

Thence along the right of way the following two courses:

- 1.) South 09 degrees 20 minutes 06 seconds East, 274.38 feet to an iron pin found;
- 2.) South 00 degrees 52 minutes 37 seconds West, 317.19 feet to an iron pin found on the north line of lands presently owned by Christopher Moore, (OR 1521-644);

Thence along the lines of said Moore lands the following two courses:

- 1.) North 88 degrees 33 minutes 17 seconds West, 470.78 feet to an iron pin found;
- 2.) South 06 degrees 00 minutes 32 seconds West, 527.33 feet to a point in said Shannon Road, passing an iron pin found at 262.14 feet, and an iron pipe found at 499.81 feet;

Thence along the centerline of said road, South 84 degrees 58 minutes 30 seconds East, 542.25 feet to a point on the west right of way of said Frazeysburg Road;

Thence along the west right of way line the following three courses:

- 1.) South 02 degrees 37 minutes 37 seconds West, 282.24 feet to an iron pin found, passing an iron pin set at 29.26 feet;
- 2.) South 87 degrees 23 minutes 10 seconds East 20.13 feet to an iron pin found;
