

3.) South 02 degrees 37 minutes 02 seconds West, 780.03 feet to an iron pin found;

Thence South 87 degrees 22 minutes 58 seconds East 45.00 feet to a point in the centerline of said Frazeyburg Road;

Thence along the centerline of said road the following two courses:

1.) South 02 degrees 37 minutes 05 seconds West, 41.22 feet to a point;

2.) Along a curve to the left, with a delta angle of 28 degrees 02 minutes 54 seconds, a radius of 1637.02 feet, an arc length of 801.38 feet, and a chord which bears South 11 degrees 24 minutes 22 seconds East, 793.40 feet to a point on the west line of lands presently owned by James R. and Marlene C. Helt, (OR 2881-333);

Thence along the west line of said Helt lands, South 01 degrees 51 minutes 20 seconds West, 394.45 feet to an iron pin set, on the section line and the north line of lands presently owned by William A. and Kristen J. Huston, (OR 2442-373), passing an iron pin found at 65.55 feet;
