PART OF AUDITORS PARCELS
44-02-14-02-000 (15.27 Acres)

Situated in the Northeast Quarter of Section 14, T-2-N, R-8-W, U.S.M.L., Muskingum Township, Muskingum County, Ohio. Being part of the lands of Richard McCarty conveyed in Deed Book 1062 page 93 of the Muskingum County Deed records and being described as follows:

Beginning at a found iron pin marking the Northwest corner of the Northeast corner of section 14;

Thence, **N.89°51'15"E.** a distance of **826.58 feet** along the North line of said quarter section to a point on the Northwest corner of the lands, now or formerly, owned by N. Sarap, trust (1900/241), located in the right of way of Fawn Drive;

Thence, **S.00°04'22"E.** a distance of **804.87 feet** along the west line of said Sarap lands to a set rebar, passing a set rebar at 20.00 feet;

Thence, **S.89°51'15"W.** a distance of **826.17 feet** through the lands of R. McCarty (1062/093) to a point on the West line of the Northeast Quarter of Section 14, located in the right of way of Gorsuch Road, passing a set rebar at 801.17 feet;

Thence, **N.00°06'05"W.** a distance of **804.87 feet** along quarter section line to the point of beginning.

The above described parcel contains **15.27 Acres**, more or less, subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.




