Situated in the State of Ohio, County of Muskingum, Township of Muskingum, Township 2N, Range 8W, part of Section 14, bounded and described as follows:

Being part of Sue Brauning Property Deed Vol. 1073, Page 73, Parcel Numbers 44-02-14-04-000 and 44-02-14-03-000.

Commencing at an iron pin found at the Southeast Corner of the Northwest Quarter of Section 14; Thence South $89^{\circ}30'19''$ West 283.43 feet to an iron pin found the place of beginning; Thence South $89^{\circ}30'19''$ West 727.73 feet to an iron pin set; Thence along the split lines of Sue Brauning Property North $02^{\circ}59'56''$ East 2003.61 feet to an iron pin set and North $85^{\circ}12'07''$ East 904.51 feet to the West line of said Quarter Section passing an iron pin at 888.66 feet; Thence along said Quarter Section in Gorsuch Road (County Rd. 307) South $00^{\circ}08'15''$ East 1872.71 feet to a point; Thence leaving Quarter Section and along a 1.24 acre split from Parcel No. 44-02-14-03-000 the next two courses and distances: South $87^{\circ}35'11''$ West 283.64 feet to an iron pin found passing an iron pin set 23.92 feet, and South $00^{\circ}08'15''$ East 185.59 feet to the place of beginning containing 43.37 acres.

Being 7.76 acres from Parcel No. 44-02-14-03-000 and 35.61 acres from Parcel No. 44-02-14-04-000.

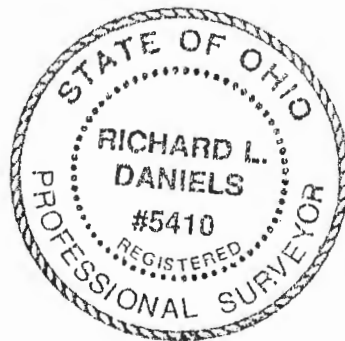
Bearings are based on the South line of Section 14 bearing South $89^{\circ}30'19''$ West.

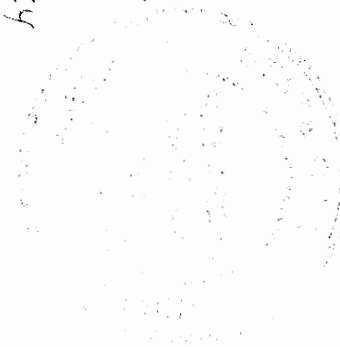
