Commencing at the southwest corner of Lot 4 in Copelands Subdivision; thence north 89 degrees 43 minutes 41 seconds east 3572.16 feet to an iron pin; thence north 0 degrees 06 minutes 25 seconds east 2067.45 feet to a point; thence north 0 degrees east 193.51 feet to the true place of beginning of the premises herein intended to be described; thence north 0 degrees east 153.76 feet to the southwest corner of a 2 acre parcel conveyed to Matthew E. and Marc E. Warner by deed recorded in Deed Book 1152, Page 377; thence along the south line of said 2 acre parcel east 253.92 feet to an iron pin found at the southeast corner of said 2 acre parcel; thence along the east line of said 2 acre parcel north 344.73 feet to an iron pin found at the northeast corner of said 2 acre parcel; thence south 15 degrees 00 minutes 27 seconds east 369.19 feet to an iron pin; thence south 67 degrees 54 minutes 18 seconds west 377.22 feet to the true place of beginning, containing one and three hundredths (1.03) acres more or less.


