**SURVEY DESCRIPTION
FOR
David McCarty**

Part of Auditors Parcel
44-12-03-35-000 (3.581 ACRES)

Situated in Lot 24, Quarter Township 3, T-2-N, R-8-W, U.S.M.L., Muskingum Township, Muskingum County, Ohio. Being part of the lands of David McCarty conveyed in Deed Book 522 Page 700 of the Muskingum County Deed records, and being described as follows:

Beginning at a point on the East line of lot 24 on the Southeast corner of the lands of D. & A. Waite (1030/93), located S.06°04'33"W. a distance of 668.50 feet from an iron pin found marking the Northeast corner of Lot 24;

Thence, S.06°04'33"W. a distance of 253.27 feet along the East line of said lot to a point;

Thence, N.71°14'49"W. a distance of 508.79 feet through the lands of D. McCarty (522/700) to a set rebar, passing a set rebar at 26.84';

Thence, N.26°49'38"W. a distance of 377.27 feet through said McCarty lands to a found rebar on the Southwest corner of the lands of D. & A. Waite (1030/93);

Thence, S.69°54'09"E. a distance of 722.87 feet along said Waite lands to the point of beginning.

The above described parcel contains **3.581 acres**, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

Attache to the above described parcel a 50 foot wide right of way for ingress and egress being described as follows:

Beginning at a point on the East line of Lot 24, located S.06°04'33"W. a distance of 921.77 feet from an iron pin found marking the Northeast corner of Lot 24; Thence, S.06°04'33"W. a distance of 332.33 feet along said lot line to a point; Thence, N.83°55'30"W. a distance of 50.00 feet to a point; Thence, N.06°04'33"E. a distance of 343.58 feet to a point on the South line of the above 3.581 acre parcel; Thence, S.71°14'49"E. a distance of 51.25 feet to the point of beginning.




SURVEY PLAT FOR DAVID McCARTY
