PART OF AUDITORS PARCELS
44-14-01-15-000 (15.48 Acres)

Situated in lot 16 of Quarter Township 3, T-2-N, R-8-W, U.S.M.L., Muskingum Township, Muskingum County, Ohio. Being part of the lands of Richard McCarty conveyed in Deed Book 1062 page 93 of the Muskingum County Deed records and being described as follows:

- Beginning at an iron pin found marking the Northwest corner of lot 16;
- Thence, **S.64°50'56"E.** a distance of **1,035.89 feet** through the lands of R. McCarty (1062/093) to a set rebar;
- Thence, **N.86°37'17"E.** a distance of **691.71 feet** through said McCarty lands to a point on the East line of Lot 16, located in the right of way of McCaslin road, passing a set rebar at 661.71';
- Thence, **S.00°27'39"E.** a distance of **318.63 feet** along said lot line and with said road to a point;
- Thence, **S.89°51'38"W.** a distance of **1,624.44 feet** through the lands of R. McCarty (1062/093) to a set rebar on the West line of lot 16, passing a set rebar at 30.00 feet;
- Thence, **N.00°30'04"W.** a distance of **722.10 feet** along said lot line to the point of beginning.

The above described parcel contains **15.48 Acres**, more or less, subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.


