

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, Township 2-N, Range 8-W, Quarter Township 4, part of the north half of Section 20 and being further described as follows.

Commencing at the northwest corner of Section 20, thence with the north line of Section 20, North 89° 26' 51" East, 1279.59 feet to a point on the centerline of Dresden Road--County Road #2--passing an existing iron pin at 1257.59 feet, thence, North 89° 43' 20" East, 1382.90 feet along the north line of Section 20 to a point marked by an iron pin-found, thence, South 01° 13' 18" East, 805.58 feet across E. Booth Trust (Deed Book 1161, Page 448) to a point at an iron pin - set, thence, South 88° 46' 42" West, 395.00 feet across the said E. Booth to the point of beginning at an iron pin - set, thence, South 18° 42' 39" West, 483.99 feet across the said E. Booth to a point at an iron pin - set, thence, South 88° 46' 42" West, 607.64 feet across the said E. Booth to a point on the centerline of Dresden Road--County Road #2, passing an iron pin - set - at 557.64 feet, thence, with the following three calls to points on the centerline of Dresden Road--County Road #2, said centerline being also the east line of S. Obenour (Deed Book 1144, Page 682), #1 North 11° 43' 03" West, 176.67 feet, #2 North 12° 48' 44" West, 176.63 feet, #3 North 12° 33' 12" West, 110.41 feet, thence, North 88° 46' 42" East, 862.00 feet, leaving Dresden Road and crossing the said E. Booth Trust to the point of beginning, passing an iron pin - set - at 50.00 feet.



