Beginning at an iron pipe found at the northwest corner of said Out Lot 1; thence S 85 09 54 E (the base of bearings for this description is the north line of Plat Book 15, Page 129) along the north line of said Out Lot 1 a distance of 209.16 feet to an iron pin set; thence S 4 48 48 W 108.16 feet to an iron pin set; thence S 60 22 18 W 71.81 feet to an iron pin set; thence N 86 29 21 W 39.80 feet to an iron pin set; thence S 6 27 56 W 65.28 feet to an iron pin set on the north line of Kenlo Woods Drive; thence S 89 22 33 W along the north line of said road 11.00 feet to an iron pipe found; thence N 81 37 47 W along the north line of said road 97.46 feet to an iron pin set on the west line of said Out Lot 1 and on the east right of way of State Route 60; thence N 4 48 08 E along the west line of said Out Lot 1 and the east line of said highway 210.00 feet to the place of beginning containing eighty five hundredths (0.85) of an acre.


