Being part of Section 20, Township 2 North, Range 8 West, and being more particularly described as follows:

Beginning for reference at the southeast corner of the Southwest Quarter of Section 20; thence along the mid-section line of Section 20 North 01 degrees 55 minutes 54 seconds East 656.78 feet (per deed) to an iron pin found on the northeast corner of lands now owned by R.L. and T. Ashcraft (DR 1158-117) and the principal place of beginning; thence along said Ashcraft's north line and the north line of lands now owned by G.D. and L.J. Edgell (DR 1143-700), South 82 degrees 32 minutes 42 seconds West 864.76 feet to an iron pin found, passing an iron pin found at 506.30 feet; thence through lands now owned by B.G. and R.A. Jasper (DR 1147-677) the following two courses:

- 1) North 26 degrees 32 minutes 27 seconds East 359.57 feet to an iron pin set;


