DESCRIPTION FOR CONVEYANCE
Grantor: KREUTER, Richard and Beatrice
(9.144 Acres±)

Situated in the State of Ohio, County of Muskingum, Township of Muskingum:

Being a part of Section Twenty-three (23) in the South Half of Quarter Township Four (4), Range Eight (8), Township Two (2), and a part of Lot One (1) in Quarter Township Three (3), Township Two (2), Range Eight (8), United States Military Lands, bounded and described as follows:

Beginning at a stone found at the Southwest corner of said Section 23, said stone also being the Southeast corner of said Lot 1; thence run North 02 degrees 23 minutes 59 seconds East along said Lot and Section line (the Basis of Bearings herein according to Survey of the same by Richard Max Graves, Registered Surveyor No. 5792, December 30, 1986) a distance of 825.08 feet to an iron pin found (GRAVES #5792) at the Southwest corner of a tract of land conveyed to John H. McCurdy and Sandra K. McCurdy (O.R. Book 1706, Page 423);

thence run South 87 degrees 38 minutes 43 seconds East along the southerly line of said McCurdy tract a distance of 140.67 feet to an iron pin found (GRAVES #5792) at the Southeast corner thereof;

thence run North 03 degrees 49 minutes 06 seconds East along the easterly line of said McCurdy tract a distance of 265.48 feet to an iron pipe found at the Northeast corner thereof;

thence run North 87 degrees 12 minutes 22 seconds West along the Northerly line of said McCurdy tract, passing into the aforementioned Lot 1 at 62.20 feet, a total distance of 172.13 feet to an iron pipe found at the Northwest corner of said McCurdy tract, said

point being the Northeast corner of a tract of land owned by Angela C. Millfelt (Vol 1131, Page 868);

thence continue North 87 degrees 12 minutes 22 seconds West along the Northerly line of said Angela C. Millfelt tract a distance of 44.77 feet to a point from which an iron pipe found bears North 87 degrees 12 minutes 22 seconds West a distance of 17.07 feet;

thence run North 13 degrees 26 minutes 38 seconds East along the Easterly line of Ridgeland Drive a distance of 50.88 feet to the Southwest corner of a tract of land conveyed to Grover Arnold, Jr. and Martha M. Arnold (Vol 858, Page 40);

thence run South 87 degrees 12 minutes 22 seconds East along the Southerly line of said Arnold tract, passing into the aforementioned Section 23 at 59.89 feet, a total distance of 444.60 feet to a point on the Easterly line of the lands of the grantor herein (Richard B. Kreuter and Beatrice E. Kreuter, Vol 629, Page 298) to a point from which an old iron pipe found bears North 02 degrees 45 minutes 16 seconds East a distance of 100.31 feet;

thence run South 02 degrees 45 minutes 16 seconds West along said Kreuter Easterly line a distance of 1,132.19 feet to the Southeast corner of said Kreuter lands, said point being marked by an iron pin found previously;

thence run North 88 degrees 37 minutes 49 seconds West along the Southerly line of said Section 23 a distance of 377.75 feet to the Place of Beginning, containing 9.144 acres, more or less. 9.070 acres, more or less, lies in Section 23 and 0.074 acre, more or less, lies in Lot 1.

Being the remainder of the said Kreuter tract of land as conveyed to them in Deed Book 629, Page 298, and being all of Muskingum County Auditor's Parcel No. 44-44-44-02-04-000.


