United States Military Lands, bounded and described as

Commencing at an iron pin at the southeast corner of Lot 9
of Wise Sub as delineated in Plat Book 9, page 23 of
Muskingum County Plat Records, said point being the place
of beginning of the following described tract; thence
S 19°13'32"E (25.53') along the west right of way of North
River Road West to a point; thence S 83°41'25"W (300.00')
along the north line of Lot 7 to the Northwest corner of
said lot; thence S 20°49'32"E (102.83') along the west line
of said lot to the northwest corner of Lot 6; thence
S 22°12'31"E (103.50') along the west line of Lot 6 to the
northwest corner of Lot 5; thence S 22°51'02"E (103.81')
along the west line of Lot 5 to the northwest corner of Lot 4;
thence S 4°51'53"E (105.00') along the west line of Lot 4 to
the northwest corner of Lot 3; thence S 2°30'04"E (106.76')
to the southwest corner of Lot 3; thence S 83°41'25"W (335.82')
along the north line of Lot 2 to an iron pin at the northeast
corner of Lot 2; thence North (525.79') along the west line
of Wise Sub to an iron pin; thence N 83°41'25"E (437.63')
to the place of beginning. Containing 3.04 acres more or less.

Subject to all legal right of ways and easements of record.

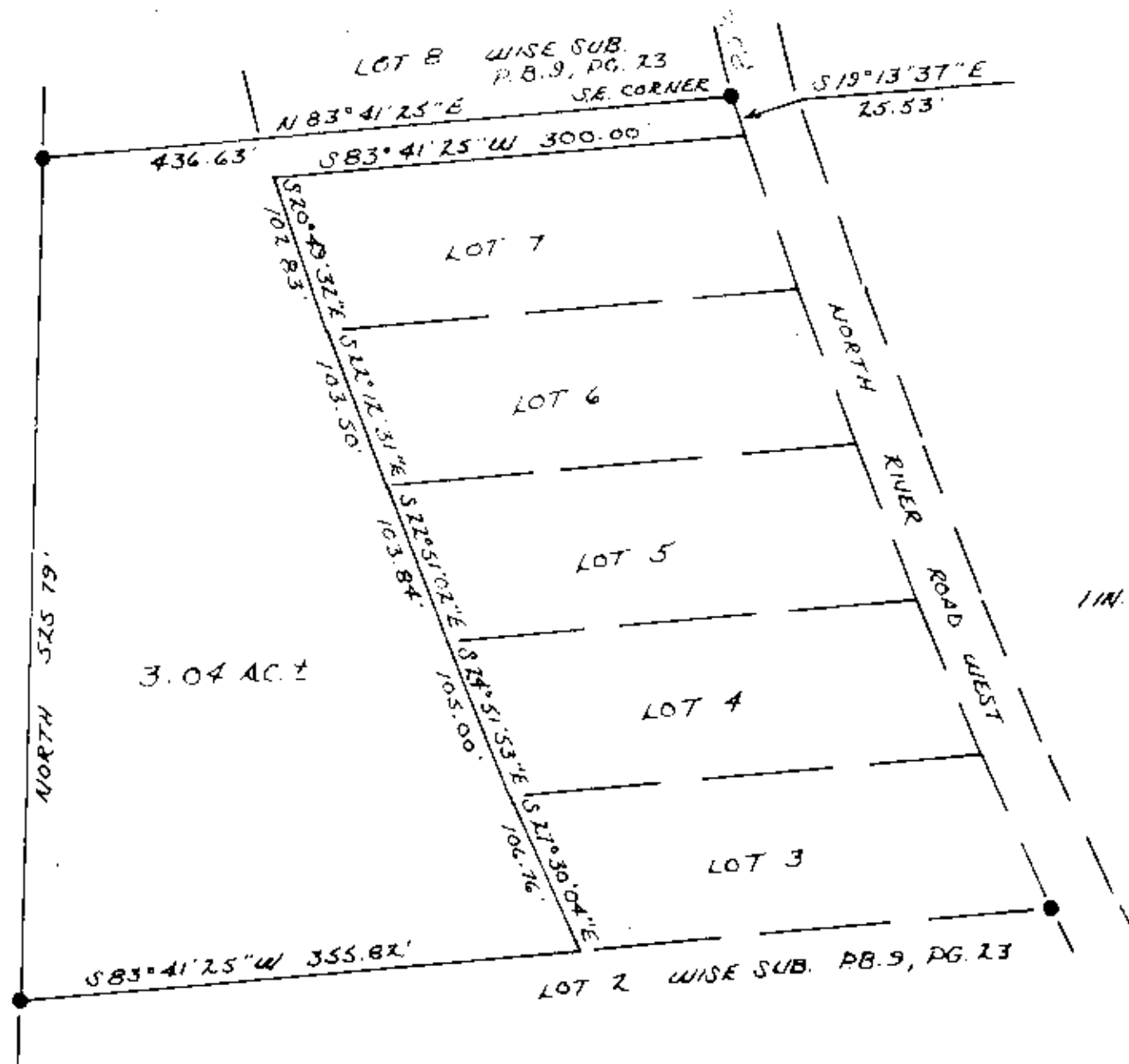
