

Survey for Joseph C. and Trudie L. Haren

Situated in Lots 2 and 3 of E.B. Webster's addition to the town of Sonora, Plat Book 1, Page 256, Township of Perry, County of Muskingum, State of Ohio and being part of the Southeast Quarter of Section 6, Township 1, Range 6, being bounded and described as follows:

Commencing for reference at an iron pin found disturbed, at the northwest corner of Lot 2 of E.B. Webster's addition to the town of Sonora, Plat Book 1, Page 256; thence with the north line of said Lot 2, South 87 degrees 57 minutes 39 seconds East, a distance of 218.71 feet to an iron pin found, thence leaving said lot line South 02 degrees 06 minutes 11 seconds West, a distance of 249.70 feet to an iron pin found at the southwest corner of property conveyed to Michael and Tracie Mitchell (Volume 1509, Page 697), said iron pin found being also the **TRUE POINT OF BEGINNING**, of the parcel herein described;

thence along the southwest line of Michael and Tracie Mitchell, South 50 degrees 22 minutes 12 seconds East, a distance of 82.05 feet to an iron pin found, passing the lot line between said lots 2 and 3 at 28.06 feet;

thence with the west property line of property conveyed to Michael and Tracie Mitchell (Volume 2024, Page 315) South 23 degrees 03 minutes 20 seconds East, a distance of 186.56 feet to point in the north right of way line of Webster Street, passing an iron pin set (Eicher S-8233) at 173.09 feet;

thence along the north right of way line of Webster Street North 88 degrees 47 minutes 37 seconds West a distance of 333.33 feet to a point, passing the lot line between said lots 2 and 3 at 122.14 feet;

thence leaving the right of way of the road and through the of property conveyed to Joseph C. and Trudie L. Haren (Volume 784, Page 52), North 07 degrees 30 minutes 18 seconds East, a distance of 269.55 feet, to an iron pin set (Eicher S-8233), passing an iron pin set (Eicher S-8233) at 3.52 feet; thence South 72 degrees 44 minutes 22 seconds East, a distance of 169.43 feet to an iron pin found, said iron pin found also being the True Point of Beginning of the Parcel herein described, containing 1.443 acres more or less.

The bearings in the above description are based on the north line of Lot 2 of E.B. Webster's addition to the town of Sonora, Plat Book 1, Page 256 as being South 87 degrees 57 minutes 39 seconds East.

Iron pins set are 5/8" rebar, 30" long with plastic ID caps "Eicher S-8233".

Subject to all right of ways, easements, restrictions, zoning regulations, either written or implied.


