BEING A PART OF PARCEL ONE AND PARCEL TWO AS CONVEYED TO DEBORAH DUNN, STEVEN MEDLEY, TERENCE MEDLEY, AND JANE BRUCE IN O.R. VOLUME 2621, PAGE 616 OF THE MUSKINGUM COUNTY OFFICIAL RECORDS. SITUATED IN THE NORTHEAST QUARTER OF SECTION 9, TOWNSHIP 1, RANGE 6, OF THE UNITED STATES MILITARY LANDS, PERRY TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE NORTHEAST CORNER OF SECTION 9;

THENCE WITH THE EAST LINE OF THE SAID SECTION 9, SOUTH 02 DEGREES 11 MINUTES 53 SECONDS WEST 661.15 FEET TO AN IRON PIN SET, SAID IRON PIN SET BEING THE **PLACE OF BEGINNING** OF THE PARCEL HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE SAID EAST LINE, SOUTH 02 DEGREES 11 MINUTES 53 SECONDS WEST 694.55 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH CAP);

THENCE WITH THE NORTH LINE OF A PARCEL CONVEYED TO TYLER D. GERMAN AND CARLEY M. GERMAN (OFFICIAL RECORD VOLUME 2824, PAGE 198) THE FOLLOWING TWO COURSES AND DISTANCES:

1. NORTH 86 DEGREES 44 MINUTES 52 SECONDS WEST 1294.23 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH ALUMINUM CAP);
2. NORTH 84 DEGREES 40 MINUTES 20 SECONDS WEST 784.70 FEET TO AN IRON PIN SET;

THENCE LEAVING THE SAID GERMAN NORTH LINE AND TRAVERSING INTO THE ABOVE SAID DUNN, MEDLEY, MEDLEY AND BRUCE PARCEL THE FOLLOWING THREE COURSES AND DISTANCES:

1. NORTH 29 DEGREES 17 MINUTES 56 SECONDS WEST 153.97 FEET TO AN IRON PIN SET;
2. NORTH 61 DEGREES 10 MINUTES 02 SECONDS WEST 227.70 FEET TO AN IRON PIN SET;
3. NORTH 12 DEGREES 32 MINUTES 26 SECONDS WEST 84.90 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE NORTHEAST CORNER OF A PARCEL CONVEYED TO TERENCE F. MEDLEY (OFFICIAL RECORD VOLUME 2867, PAGE 353);

THENCE WITH THE NORTH LINE OF THE SAID MEDLEY PARCEL, NORTH 86 DEGREES 09 MINUTES 49 SECONDS WEST, PASSING AN IRON PIN SET AT 263.84 FEET, A TOTAL DISTANCE OF 297.50 FEET TO A POINT ON THE WEST LINE OF THE NORTHEAST QUARTER OF SECTION 9 (SAID POINT ALSO BEING IN ARCH HILL ROAD-COUNTY ROAD 82);

THENCE WITH THE SAID WEST LINE, NORTH 02 DEGREES 15 MINUTES 00 SECONDS EAST 264.71 FEET TO A POINT;

THENCE LEAVING THE SAID QUARTER SECTION LINE AND TRAVERSING INTO THE ABOVE SAID DUNN, MEDLEY, MEDLEY AND BRUCE PARCEL THE FOLLOWING FOUR COURSES AND DISTANCES:

1. NORTH 85 DEGREES 45 MINUTES 19 SECONDS EAST, PASSING AN IRON PIN SET AT 33.23 FEET, A TOTAL DISTANCE OF 136.50 FEET TO AN IRON PIN SET;
2. NORTH 61 DEGREES 38 MINUTES 28 SECONDS EAST 36.93 FEET TO AN IRON PIN SET;
3. NORTH 83 DEGREES 42 MINUTES 12 SECONDS EAST 235.03 FEET TO AN IRON PIN SET;
