- TIE-2 THENCE with a curve to the left having, a chord bearing South 62 degrees 16 minutes 21 seconds West 205.58 feet, a radius of 286.75 feet, and arc length of 210.26 feet into the Southwest Quarter of Section 1, along said road and common line for said Ufholz property and for a second Kurt A Ufholz and Pamela K Ufholz property recorded in Official Record Volume 2726, Page 453 to an unmarked point;
