Being a part of the Northeast Quarter of Section 14, Township 1, Range 6 of the United States Military Lands and part of Parcel D and all of Parcel E of property owned by Kole Busche and Kroy Busche and Recorded in Official Record Book 2131, Page 133 in said Muskingum County bounded and described as follows:

Commencing at an iron pin found at the northeast corner of the northeast quarter of said section 14; thence **N 88°32'18"W** (the base of bearings is State Plane Grid from a Solar Observation) along the north line of said section **548.58** feet to an iron pin found; thence **S 1°35'37"W 1499.55** feet to an iron pin found; thence **N 87°57'11"W** along the south line of property owned by Jared E. Michel (O.R. 2664, Pg. 324) **564.39** feet to an iron pin set at the southwest corner of said Michael Property and the **True Place of Beginning** for the following described parcel; thence continuing **N 87°57'11"W** along the north line of a 150 acre farm parcel (Vol. 46, Pg. 439) and the north line of property owned by Scott and Terry Johnson (O.R. 1944, Pg. 416) and along the south line of 4.194 acre parcel "D" 1995 survey a distance of **187.35** feet to a point that bears **N7°30'56"W 0.32** of a foot from an axle found; thence continuing **N 87°57'11"W** along the north line of property owned by Randall and Linda Bates (Vol. 803, Pg. 40) and along the south line of Parcel "E" of said 1995 Survey **311.12** feet to a point in the center of Bald Hill Road and passing **0.33** of a foot north of an axle at **284.87** feet; thence **N28°16'01"W** along the center of Bald Hill Road and along the east line of a 20.10 acre parcel owned by Randy and Kristine Triplett (O.R. 1644, Pg. 535) **106.97** feet to a point; thence **N 83°42'04"E** along the north line of said Parcel E (2131, Pg. 133) and the south line of Parcel "F" still owned by Paul Busche and part of original 10.17 acres (1104, Pg. 429) a distance of **324.48** feet to an iron pin found to the northeast corner of said Parcel "E" and passing through an iron pin found at **38.18** feet; thence **N 11°58'16"W** along the east line of said Paul Busche property and along the west line of said Parcel "D" a distance of **98.39** feet to an iron pin found; thence **S 87°35'29"E** along the south line of Parcel "B" owned by William and Patricia Busche (O.R. 1947, Pg. 320) a distance of **253.41** feet to an iron pin set at the northwest corner of said Jared E. Michel (O.R. 2664, Pg. 324); thence **S 1°35'37"W** along the west line of said Michel property **233.31** feet to the True Place of Beginning containing **2.061** acres.




