

Situated in the State of Ohio, County of Muskingum, Township of Perry.

Being a part of fractional Section 14 in Township 1, Range 6 bounded and described as follows:

Commencing at a stone found at the Southwest Corner of Fractional Section 14; thence south 88 degrees 28 minutes east 1932.76 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence north 5 degrees 47 minutes 06 seconds east 341.99 feet to a point in the center of Boggs Road; thence along the center of said road the following five (5) courses and distances, north 86 degrees 02 minutes east 328.22 feet to a point; thence on a curve to the right having a radius of 54.48 feet an arc length of 86.87 feet (the chord of which bears south 48 degrees 17 minutes 06 seconds east 77.96 feet) to a point; thence south 2 degrees 36 minutes 12 seconds east 228.79 feet to a point; thence on a curve to the left having a radius of 85.68 feet an arc length of 128.64 feet (the chord of which bears south 45 degrees 37 minutes 07 seconds east 116.89 feet) to a point; thence south 88 degrees 38 minutes 02 seconds east 36.39 feet to a point; thence leaving said centerline south 5 degrees 34 minutes 17 seconds east 14.74 feet to a point on the south line of said fractional Section 14; thence along said south line north 88 degrees 28 minutes west 552.04 feet to the true place of beginning, containing three and forty-two hundredths (3.42) acres more or less.

Subject to the easements of Boggs Road.


