

## DESCRIPTION OF SURVEY FOR EBER QEDYKE

JOB #341-3

Situated in the State of Ohio, County of Muskingum, Township of Perry, North Half of Section #15, of Township #1, Range #6 of the US Military District;

Being part of the prior deed reference Volume 587, Page 22 of the Muskingum County deed records, also being all of the Muskingum County Auditor's Parcel Number 51-51-30-15-11-000, and is more particularly described as follows;

Commencing at the intersection of Lectric Lane (Township Road #1432) and Sonora Road (County Road #52) as shown on the Plat of said Lectric Lane in Plat Book 10, Page 62 of said county's plat records; thence along the center of said Sonora Road N 02 56 38 E 145.80 feet to the Northeast corner of the property described in deed reference Volume 846, Page 303, also being the place of beginning for the property herein intended to be described;

#1- thence along the North line of said Volume 846, Page 303 N 87 09 21 W 185.20 feet to an iron pipe (found) at a common corner of said Volume 846, Page 303 and the property described in deed reference Volume 853, Page 5, passing an iron pipe (found) at 20.00 feet;

#2- thence along the East line of said Volume 853, Page 5 N 02 43 32 E 54.36 feet to an iron pin (found) at a common corner of said Volume 853, Page 5 and the property described in deed reference Volume 864, Page 27;

thence along the lines of said Volume 864, Page 27 and the South bank of Little Salt Creek the following five courses-

#3- thence S 87 42 49 E 44.83 feet to an iron pipe (found);

#4- thence N 28 10 34 E 65.75 feet to an iron pipe (found);

#5- thence N 25 34 23 E 23.49 feet to an iron pipe (found);

#6- thence N 78 24 53 E 28.15 feet to an iron pin (found);

#7- thence S 89 15 21 E 80.79 feet to the center of said Sonora Road as described in said Volume 864, Page 27, passing an iron pin (set) at 49.98 feet;

#8- thence along the center of said Road S 04 41 52 W 145.95 feet to the place of beginning containing 0.484 acres.

The bearings within this description are based on true North derived from a Solar Observation (Local Hour Angle Method) taken on the property. Iron pins (set) are 5/8" rebar with aluminum identification caps ( C R Harkness R S 6885 ).



The bearings on this plat are based on a Solar Observation (Local Hour Angle Method) completed on the property.


