Situated in Quarter Township 3, T-1-N, R-6-W, U.S.M.L., Perry Township, Muskingum County, Ohio. Being part of the lands of Jay and Lois Gruenebaum conveyed in Deed Book 1151 Page 831 of the Muskingum County Deed Records, and being described as follows:

Commencing at an iron pin found marking the Northeast corner of Lot "C" of Durbin Heights, NO. 2, (P.B. 15, Pg. 47); Thence, N.68°02'57"E. a distance of 119.63 feet along the South line of Shimoda Lane to a point; thence, N.21°57'03"W. a distance of 50.32 feet across said Lane to a found iron pin on the Southeast corner of the lands, now or formerly, owned by E. Opdyke (521/012), BEING THE POINT OF BEGINNING;

Thence, N.19°06'33"W. a distance of 279.63 feet along said Opdyke lands to a found iron pin;

Thence, N.02°56'03"W. a distance of 39.20 feet along said Opdyke lands to a found iron pin;

Thence, N.02°54'13"W. a distance of 25.05 feet along said Opdyke lands to a found iron pin;

Thence, N.24°40'52"W. a distance of 74.58 feet along said Opdyke lands to a found iron pin;

Thence, N.04°20'50"W. a distance of 49.43 feet along said Opdyke lands to a found iron pin;

Thence, S.89°12'47"E. a distance of 139.37 feet along said Opdyke lands to a set rebar;

Thence, S.17°04'13"E. a distance of 409.26 feet through the lands of J. & L. Gruenebaum (1151/831) to a found iron pin on the North line of Shimoda Lane;

Thence, S.68°02'57"W. a distance of 139.93 feet along said lane to the point of beginning.

The above described parcel contains 1.43 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.


