Being a part of the Northwest Quarter of Section 12, Township 1, Range 6 bounded and described as follows:

Commeucing at the southeast corner of the Northwest Quarter of Section 12, thence north 56.16 feet to a point in the center of State Route #40; thence along said centerline south 70 degrees 33 minutes west 84.84 feet to the southeast corner of a 3.22 acre parcel conveyed to Roy G. Isaacs and Doris J. Isaacs by deed recorded in Deed Book 943, Page 49 and also being the true place of beginning of the premises herein intended to be described; thence north 3 degrees 50 minutes 32 seconds west 419.19 feet to a point; thence east 28.09 feet to a point at the northwest corner of a 0.74 acre parcel conveyed to Jack B. Bogart and Sharon H. Bogart by deed recorded in Deed Book 942, Page 87; thence along the west line of said Bogart Parcel south a distance of 418.25 feet to the true place of beginning, containing thirteen hundredths (0.13) of an acre more or less.


