BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 13, TOWNSHIP 1, RANGE 6, OF THE UNITED STATES MILITARY LANDS, PERRY TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (AXLE) AT THE SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF SECTION 13;

THENCE WITH THE SOUTH LINE OF SAID SOUTHEAST QUARTER, SOUTH 87 DEGREES 38 MINUTES 05 SECONDS EAST 454.88 FEET TO A POINT IN THE CENTER OF COUNTY ROAD 5, SAID POINT BEING THE SOUTHWEST CORNER OF A 1.096 MORE OR LESS ACRE TRACT CONVEYED TO D. & S. SPILLMAN BY DEED RECORDED IN VOLUME 915, PAGE 233 OF THE MUSKINGUM COUNTY DEED RECORDS;

THENCE WITH THE CENTER OF SAID ROAD AND THE WEST LINE OF THE SPILLMAN TRACT THE NEXT TWO COURSES AND DISTANCES:

- 1) NORTH 31 DEGREES 04 MINUTES 36 SECONDS WEST 69.37 FEET TO A POINT;
- 2) NORTH 33 DEGREES 21 MINUTES 52 SECONDS WEST 30.05 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE CENTER OF SAID ROAD NORTH 36 DEGREES 21 MINUTES 08 SECONDS WEST 296.32 FEET TO A POINT;

THENCE LEAVING THE SAID ROAD AND TRAVERSING INTO THE MARILYNN PATTON TRACT (VOLUME 817, PAGE 89) THE NEXT TWO COURSES AND DISTANCES:

- 1) NORTH 59 DEGREES 50 MINUTES 07 SECONDS EAST 337.25 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 25.07 FEET;
- 2) SOUTH 36 DEGREES 21 MINUTES 08 SECONDS EAST 296.32 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR-SPILKER) AT THE NORTHEAST CORNER OF THE ABOVE SAID SPILLMAN TRACT;

THENCE WITH THE NORTH LINE OF THE SPILLMAN TRACT, SOUTH 59 DEGREES 50 MINUTES 07 SECONDS WEST 337.25 FEET TO THE PLACE OF BEGINNING, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR-SPILKER) AT 297.25 FEET.

CONTAINING 2.281 MORE OR LESS ACRES, SUBJECT TO ALL LEGAL ROAD RIGHT OF WAYS OF COUNTY ROAD 5 AND ALL OTHER APPLICABLE EASEMENTS.

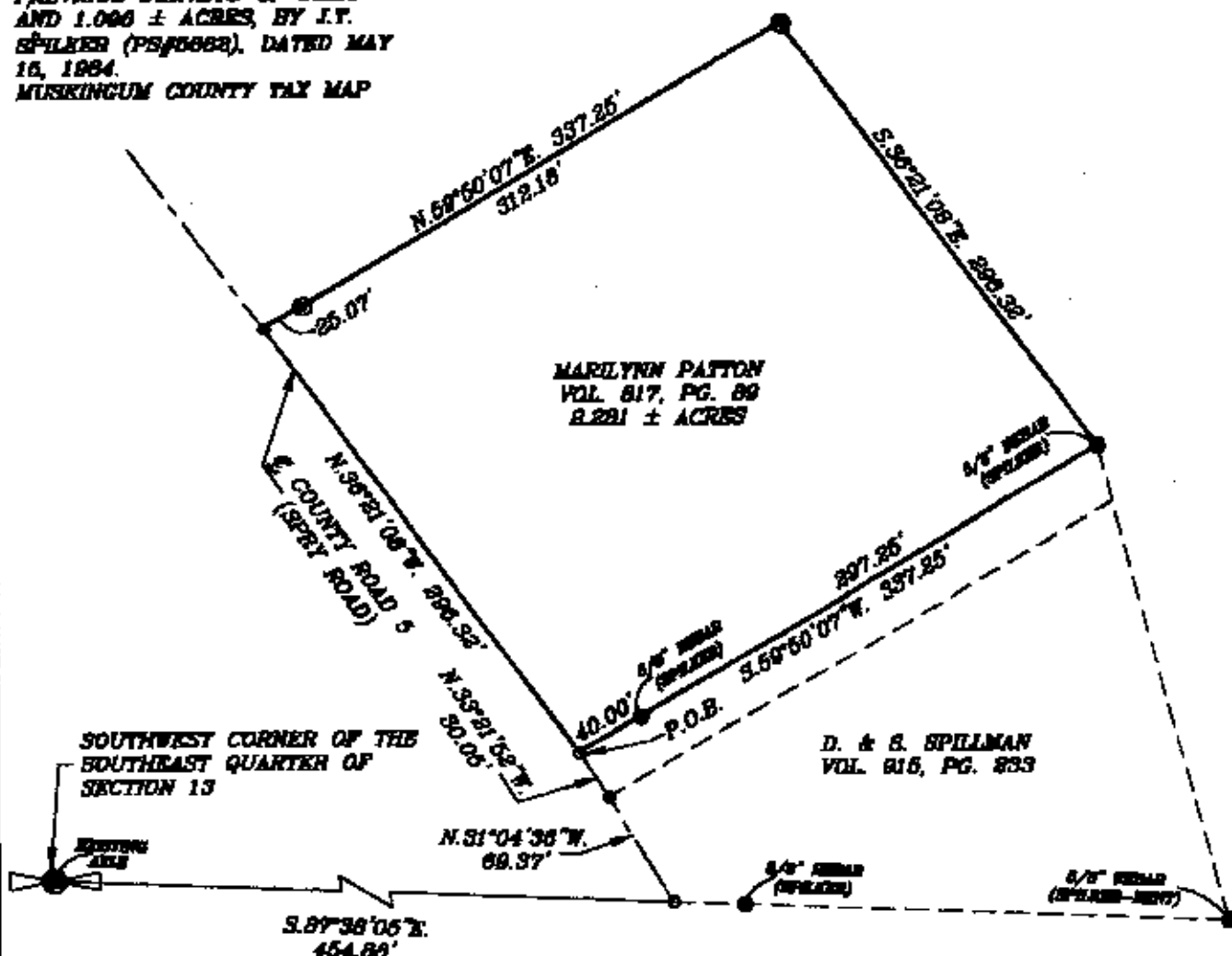
