The following calls from the stone at the center of Quarter Township 3 to the point of beginning copied from Deed Book 1011, Page 369 (K.R. & Weber to J.A. Mills). Commencing at an existing stone at center of Quarter Township 3, thence South 05° 55' 00" West, 1080 feet to an existing iron pin at the southeasterly corner of a parcel recorded in Deed Book 549, Page 49, thence South 83° 45' 30" East along the northerly line of an ingress-egress easement 98.19 feet to a point, thence South 68° 35' 30" East, 173.06 feet along said easement to an existing iron pin at the southeast corner of J.A. Mills (Deed Book 1011, Page 369) at the true place of beginning of the parcel herein being described; thence, North 6° 55' 31" West, 160.96 feet along the east line of said J.A. Mills to a point at an iron pin (set), thence, North 84° 06' 37" East, 163.72 feet across R. E. Weber (Deed Book 485, Page 496) to a point at an iron pin (set), thence, South 00° 57' 56" East, 191.53 feet across said R. E. Weber to a point at an iron pin (set), thence, North 84° 11' 25" West, 147.43 feet across said R. E. Weber to the place of beginning, Containing 0.624 acres more or less.

INGRESS-EGRESS EASEMENT
