

Road Dedication of Prosperity Parkway

Being a part of land located in the State of Ohio, Muskingum County, Perry Township, part of Quarter Township 3, Township 1 North, Range 6 West, United States Military Lands, bounded and described as follows:

Commencing at the southwest corner of the northwest quarter of Quarter Township 3; thence along the south line of said northwest quarter, South 87 degrees 34 minutes 06 seconds East 843.95 feet to an iron pin found;

thence continuing along the south line of said northwest quarter, South 87 degrees 34 minutes 06 seconds East 642.06 feet to an iron pin found, being the northeast corner of Cynthia Merry (DR 2985-199);

thence continuing along the south line of said northwest quarter, and through the Zanesville-Muskingum County Port Authority (DR 2794-24), South 87 degrees 34 minutes 06 seconds East 679.05 feet to an iron pin set, the **place of beginning** for this road dedication;

thence through the Zanesville-Muskingum County Port Authority (DR 2794-24) the following nineteen courses:

1. North 02 degrees 15 minutes 43 seconds East 1,167.33 feet to an iron pin set;
2. North 87 degrees 44 minutes 17 seconds West 10.00 feet to an iron pin set;
3. On a curve to the right having a radius of 1,035.00 feet, a delta angle of 31 degrees 05 minutes 59 seconds, a chord bearing and distance of North 18 degrees 00 minutes 33 seconds East 561.79 feet to an iron pin set;
4. North 33 degrees 45 minutes 23 seconds East 302.08 feet to an iron pin set;
5. On a curve to the left having a radius of 1,040.00 feet, a delta angle of 19 degrees 14 minutes 57 seconds, a chord bearing and distance of North 24 degrees 07 minutes 55 seconds East 347.76 feet to an iron pin set;
6. North 75 degrees 29 minutes 34 seconds West 15.00 feet to an iron pin set;
7. On a curve to the left having a radius of 275.00 feet, a delta angle of 45 degrees 10 minutes 21 seconds, a chord bearing and distance of North 08 degrees 04 minutes 43 seconds West 211.24 feet to an iron pin set on the south right-of-way of East Pike (United States 40/22);
8. Along the south right-of-way of East Pike (United States 40/22) on a curve to the right having a radius of 2,824.93 feet, a delta angle of 01 degrees 59 minutes 06 seconds, a chord bearing and distance of North 62 degrees 24 minutes 43 seconds East 97.87 feet to a point;
9. Along the south right-of-way of East Pike (United States 40/22) South 26 degrees 35 minutes 44 seconds East 10.00 feet to a point;
10. Along the south right-of-way of East Pike (United States 40/22) on a curve to the right having a radius of 2,814.93 feet, a delta angle of 01 degrees 04 minutes 22 seconds, a chord bearing and distance of North 63 degrees 56 minutes 27 seconds East 52.70 feet to a point;
11. Leaving the south right-of-way of East Pike (United States 40/22) on a curve to the right having a radius of 425.00 feet, a delta angle of 42 degrees 32 minutes 51 seconds, a chord bearing and distance of South 06 degrees 45
