

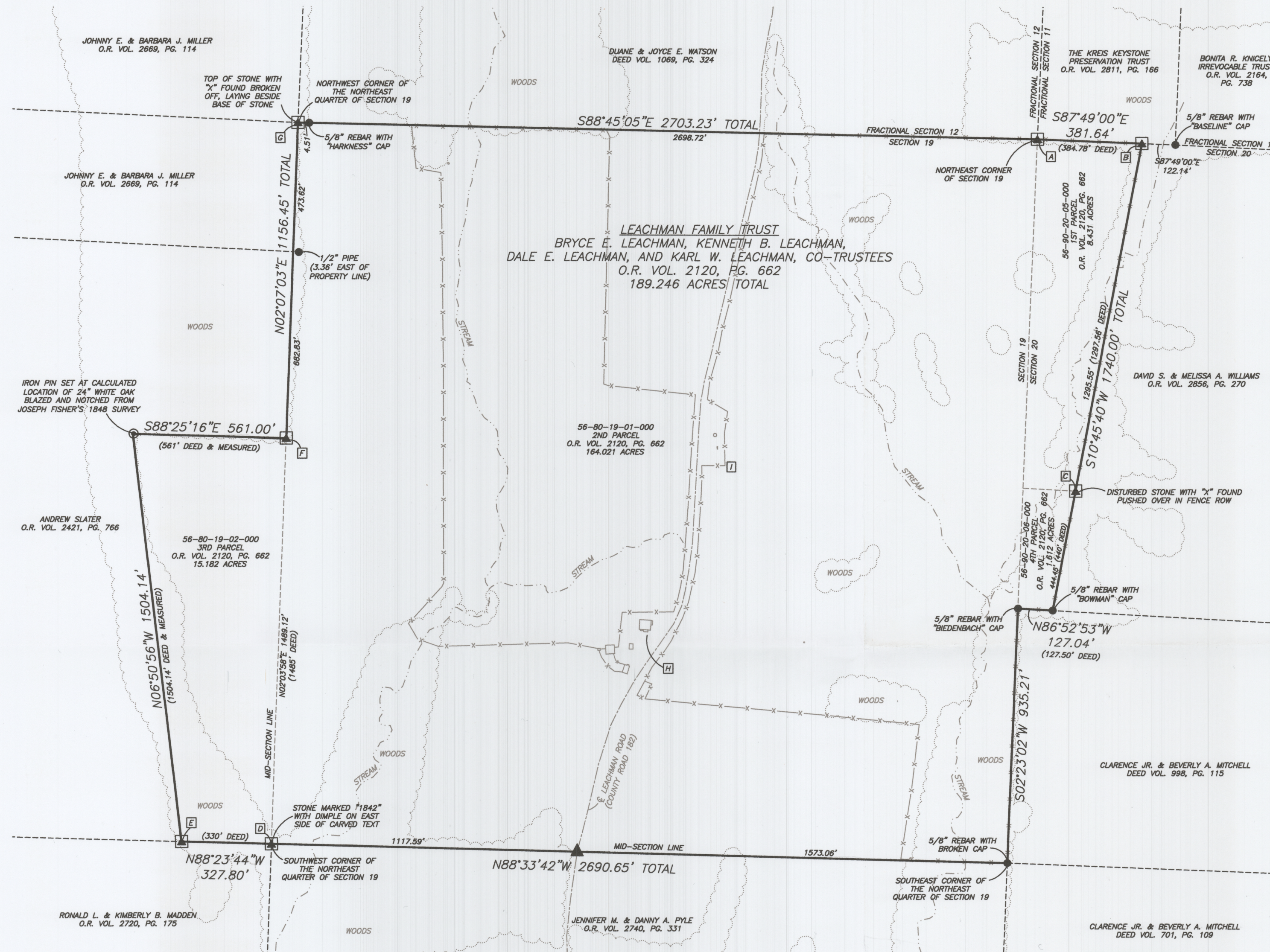

THENCE WITH THE NORTH LINE OF SECTION 20 (ALSO BEING THE SOUTH LINE OF A PARCEL CONVEYED TO THE KREIS KEYSTONE PRESERVATION TRUST IN O.R. VOLUME 2811, PAGE 166), SOUTH 87 DEGREES 49 MINUTES 00 SECONDS EAST 381.64 FEET TO AN EXISTING STONE (WITH "X") AT THE NORTHWEST CORNER OF A PARCEL CONVEYED TO DAVID S. AND MELISSA A. WILLIAMS IN O.R. VOLUME 2856, PAGE 270, SAID STONE BEING NORTH 87 DEGREES 49 MINUTES 00 SECONDS WEST 122.14 FEET FROM AN EXISTING IRON PIN (5/8" INCH REBAR WITH "BASELINE" CAP);
THENCE LEAVING THE SAID SECTION LINE AND WITH THE WEST LINE OF THE SAID WILLIAMS PARCEL, SOUTH 10 DEGREES 45 MINUTES 40 SECONDS WEST 1740.00 FEET TO AN EXISTING IRON PIN (5/8" INCH REBAR WITH "BOWMAN" CAP) ON THE NORTH LINE OF A PARCEL CONVEYED TO CLARENCE JR. AND BEVERLY A. MITCHELL IN DEED VOLUME 998, PAGE 115 OF THE MUSKINGUM COUNTY DEED RECORDS;
THENCE WITH THE NORTH LINE OF THE SAID MITCHELL PARCEL, NORTH 86 DEGREES 52 MINUTES 53 SECONDS WEST 127.04 FEET TO AN EXISTING IRON PIN (5/8" INCH REBAR WITH "BIDENBACH" CAP) ON THE EAST LINE OF THE SAID SECTION 19 (ALSO BEING AT THE NORTHWEST CORNER OF THE SAID MITCHELL PARCEL);
THENCE WITH THE EAST LINE OF SECTION 19 (ALSO BEING THE WEST LINE OF THE SAID MITCHELL PARCEL), SOUTH 02 DEGREES 23 MINUTES 02 SECONDS WEST 935.21 FEET TO AN EXISTING IRON PIN (5/8" INCH REBAR WITH BROKEN CAP) AT THE SOUTHEAST CORNER OF SECTION 19 (ALSO BEING AT THE NORTHEAST CORNER OF A PARCEL CONVEYED TO JENNIFER M. AND DANNY A. PYLE IN O.R. VOLUME 2740, PAGE 331);
THENCE WITH THE SOUTH LINE OF THE NORTHEAST QUARTER OF SECTION 19 (ALSO BEING THE NORTH LINE OF THE SAID PYLE PARCEL), NORTH 88 DEGREES 33 MINUTES 42 SECONDS WEST 2690.65 FEET TO AN EXISTING STONE (WITH "X") AT THE SOUTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 19 (ALSO BEING THE NORTHEAST CORNER OF A PARCEL CONVEYED TO RONALD L. AND KIMBERLY B. MADDEN IN O.R. VOLUME 2720, PAGE 175), PASSING AN EXISTING RAILROAD SPIKE IN THE CENTER OF LEACHMAN ROAD (COUNTY ROAD 182) AT 1573.06 FEET;
THENCE WITH THE SOUTH LINE OF THE NORTHWEST QUARTER OF SECTION 19 (ALSO BEING THE NORTH LINE OF THE SAID MADDEN PARCEL), NORTH 88 DEGREES 23 MINUTES 44 SECONDS WEST 327.80 FEET TO AN EXISTING STONE (WITH "X") AT THE SOUTHEAST CORNER OF A PARCEL CONVEYED TO ANDREW SLATER IN O.R. VOLUME 2421, PAGE 766;
THENCE WITH THE EAST LINE OF THE SAID SLATER PARCEL, THE FOLLOWING TWO COURSES AND DISTANCES:
1. NORTH 06 DEGREES 50 MINUTES 58 SECONDS WEST 1504.14 FEET TO AN IRON PIN SET;
2. SOUTH 88 DEGREES 25 MINUTES 18 SECONDS EAST 561.00 FEET TO AN EXISTING STONE (WITH "X") ON THE WEST LINE OF THE NORTHEAST QUARTER OF SECTION 19;
THENCE CONTINUING WITH THE EAST LINE OF THE SAID SLATER PARCEL AND WITH THE EAST LINE OF A PARCEL CONVEYED TO JOHNNY E. AND BARBARA J. MILLER IN O.R. VOLUME 2669, PAGE 114, NORTH 02 DEGREES 07 MINUTES 03 SECONDS EAST 1156.45 FEET TO AN EXISTING STONE (BROKEN TOP WITH "X") AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 19;
THENCE WITH THE NORTH LINE OF THE SAID SECTION 19 (ALSO BEING THE SOUTH LINE OF A PARCEL CONVEYED TO DUANE AND JOYCE E. WATSON IN DEED VOLUME 1069, PAGE 324), SOUTH 88 DEGREES 45 MINUTES 05 SECONDS EAST, PASSING AN EXISTING IRON PIN (5/8" INCH REBAR WITH "HARKNESS" CAP) AT 4.51 FEET, A TOTAL DISTANCE OF 2703.23 FEET TO THE PLACE OF BEGINNING.
