EAST) 140.00 FEET ALONG THE SAID WEST LINE TO AN EXISTING IRON PIN (5/8  
INCH REBAR) ON THE SOUTH RIGHT-OF-WAY OF I-70; THENCE SOUTH 86 DEGREES




