Part of Parcel No. 62-10-01-20-000

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being a part of the Southwest Quarter of Section Three (3), Township Sixteen (16), Range Fourteen (14) of the Congress Lands East of the Scioto River and part of property now owned by Jerry and Patricia Bradley (Vol. 1112, pg. 418) of the Muskingum County Deed Records bounded and described as follows:

Commencing at an iron pin found (5/8" rebar) at the northeast corner of said southwest quarter of section 3; thence S 2° 57' 04" W (the base of bearings for this description is State Plane Grid from a Solar Observation) along the east line of said quarter 618.62 feet to a point at the true place of beginning for the following described parcel; thence continuing S 2° 57' 04" W along the east line of the grantors property and the west line Pamela Jean and Michael R. Potts (Vol. 1506, pg. 240) and the west line of property owned by Lloyd and Kelly Treadway (Vol. 1097, pg. 410) a distance of 273.74 feet to a 3/4" pipe found and passing an iron pin found at the southwest corner of said Potts property at 252.81 feet; thence S 3° 00' 47" W along the east line of the grantors property and the west line of property owned by Boyd and Ruth Potts (Vol. 1125, pg. 371) 210.18 feet to an iron pin set; thence S 86° 38' 47" W along the north line of property owned by said Potts and properties owned by Richard Webb (Vol. 1528, pg. 313), Bonnie Sims (Vol. 1134, pg. 151), Mary Drabik (Vol. 1025, pg. 55) a distance of 277.20 feet to an iron pin set; thence N 7° 15' 44" W 370.61 feet to an iron pin set; thence N 73° 26' 26" W 180.20 feet to an iron pin found; thence S 86° 48' 13" E along the south line of property owned by Randy and Raymond Wilkes (Vol. 1153, pg. 982) 236.38 feet to an iron pin found; thence N 71° 49' 55" E along said Wilkes south line 300.40 feet to the true place of beginning and passing through an iron pin found at 298.15 feet, containing Three and twenty-four hundredths (3.24) acres.

3 - N 86° 48' 13" W 77.44 feet; thence the following 3 courses along the center of said existing gravel drive to the center of Ridge Road:

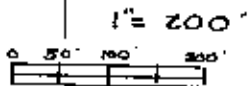
1 - S 7° 21' 09" E 384.05 feet

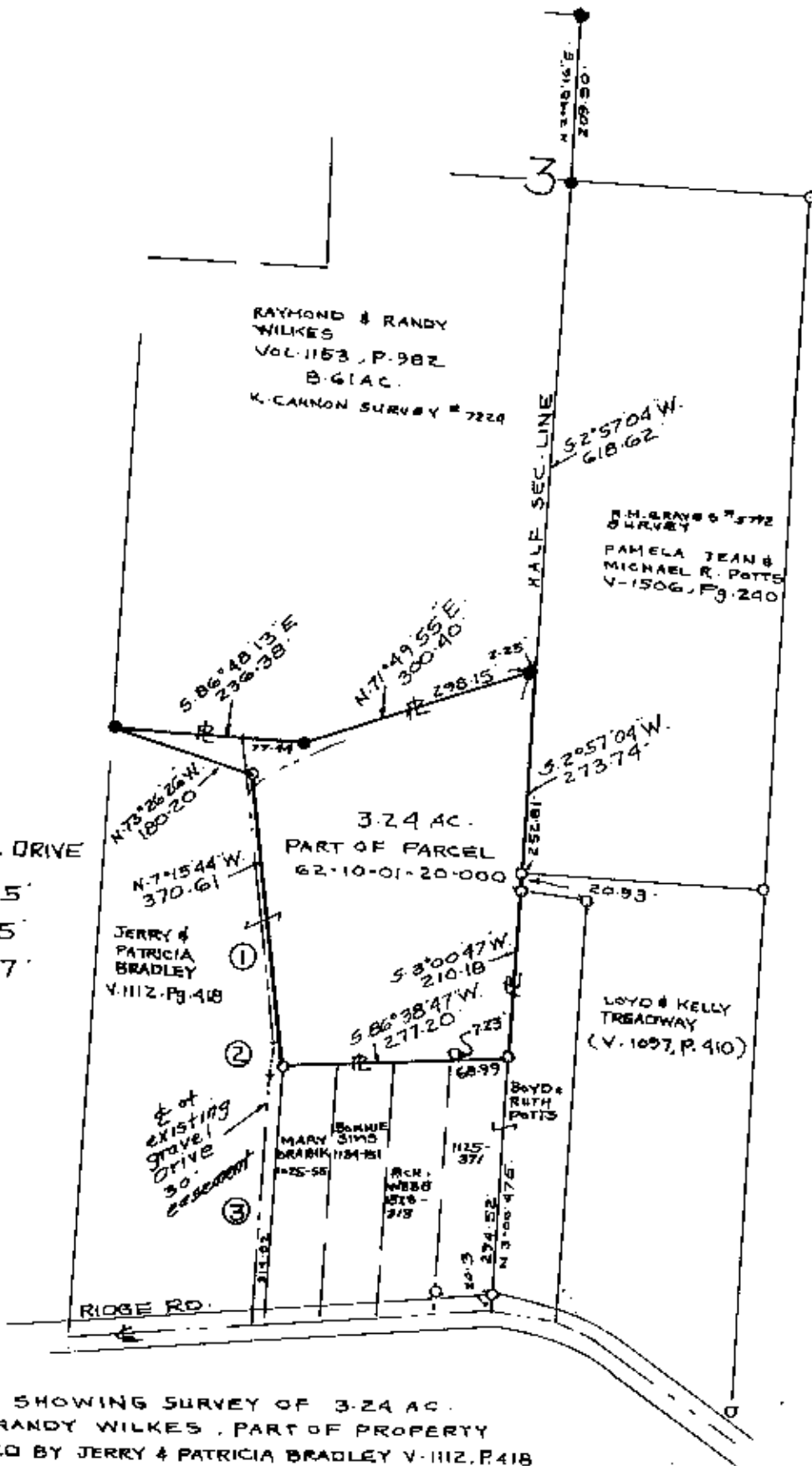
