Commencing at a corner post at the southwest corner of said northeast quarter; thence north along the half section line a distance of 297.00 feet to a railroad spike; thence north 34 degrees 10 minutes 50 seconds east along Shiplett Road a distance of 73.11 feet to the true place of beginning for the parcel herein intended to be described; thence continuing north 34 degrees 10 minutes 50 seconds east along said road a distance of 254.92 feet to a point; thence south 54 degrees 02 minutes 52 seconds east a distance of 166.62 feet to an iron pin and passing through an iron pin at 20.91 feet; thence south 06 degrees 06 minutes 53 seconds west a distance of 170.46 feet to an iron pin; thence north 73 degrees 38 minutes 35 seconds west a distance of 259.16 feet to the true place of beginning and passing through an iron pin at 161.07 feet, containing 0.95 acres more or less. 0.17 acres in one parcel and 0.78 acres in one parcel.

Subject to the easements of all legal highways.



MUSKINGUM COUNTY, OHIO.


