R Whitaker Vol. 762 Pg. 120 South 89 Degrees 29 Minutes 52 Seconds East 733.10 feet to an iron pin found; thence along William Merideth Vol. 868 Pg. 246 the next 2 courses: South 20 Degrees 56 Minutes 31 Seconds West 266.03 feet to an iron pin found; thence South 59 Degrees 11 Minutes 40 Seconds East 434.60 feet to an iron pin set; thence with new lines the next 11 courses: South 22 Degrees 16 Minutes 52 seconds West 532.79 feet to an iron pin set; thence South 84 Degrees 25 Minutes 00 Seconds West 48.33 feet to an iron pin set; thence North 73 Degrees 23 Minutes 00 Seconds West 57.59 feet to an iron pin set; thence North 51 Degrees 45 Minutes 16 Seconds West 25.45 feet to an iron pin set; thence North 25 Degrees 51 Minutes 24 Seconds West 53.11 feet to an iron pin set; thence North 31 Degrees 13 Minutes 47 Seconds West 74.89 feet to an iron pin set; thence South 66 Degrees 35 Minutes 57 Seconds West 32.95 feet to an iron pin set; thence South 21 Degrees 00 Minutes 39 Seconds West 134.94 feet to an iron pin set; thence North 66 Degrees 12 Minutes 10 Seconds West 309.80 feet to an iron pin set; thence South 11 Degrees 49 Minutes 54 Seconds West 740.66 feet to an iron pin set; thence North 71 Degrees 56 Minutes 37 Seconds West 148.49 feet to an iron pin set on the Mid Section Line; thence along said line along Margaret Perine Vol. 776 Pg. 124 & R.M. & S.R. Whitaker Vol. 762 Pg. 120 North 01 Degrees 10 Minutes 13 Seconds East 1524.37 feet to the place of beginning, containing 20.619 acres, more or less, subject to all legal highways and easements.




