POLK OF DEED BOOK 762, PAGE 73, BOUNDED ON THE SOUTH BY THE AFORESAID "MAYSVILLE DEVELOPMENT LTD" PROPERTY AND IS BOUNDED ON THE WEST BY THE PROPERTY OF JASON A. and JULIE L. LEE OF OFFICIAL RECORD BOOK 1903, PAGE 888, ALL OF THE MUSKINGUM COUNTY RECORDER ]

**BEGINNING AT AN EXISTING IRON PIN MARKING THE NORTHEAST CORNER OF LOT #3 IN SAID "DOGWOOD ESTATES SUBDIVISION";**

**THENCE S 3° 11' 17" W 349.89 FEET, IN THE EAST LINE OF SECTION #8 AND IN THE WEST BOUNDARY OF THE AFORESAID "POLK" PROPERTY, TO AN IRON PIN SET;**

**THENCE, LEAVING THE EAST LINE OF SECTION #8 AND SAID "POLK" PROPERTY, N 73° 00' 00" W 378.46 FEET TO AN IRON PIN SET;**

**THENCE S 85° 58' 00" W 303.71 FEET TO A POINT IN THE CENTERLINE OF, 50.00 FEET WIDE, COUNTRYWOOD DRIVE, PASSING AN IRON PIN SET IN THE EASTERLY RIGHT OF WAY LINE OF "COUNTRYWOOD DRIVE" AT 277.24 FEET;**

**THENCE N 23° 12' 00" W 75.00 FEET, IN THE CENTERLINE OF "COUNTRYWOOD DRIVE" AND IN THE AFORESAID "LEE" BOUNDARY, TO A POINT MARKING THE NORTHWEST CORNER OF LOT #3;**

**THENCE, LEAVING "COUNTRYWOOD DRIVE" AND SAID "LEE" PROPERTY, N 75° 00' 44" E 739.02 FEET, IN THE NORTH LINE OF "LOT #3" AND IN THE AFORESAID "PENROSE" BOUNDARY, TO AN "EXISTING IRON PIN" MARKING THE NORTHEAST CORNER OF "LOT #3" AND THE "PLACE OF BEGINNING" OF THIS 2.84 ACRE**

PARCEL, PASSING EXISTING IRON PINS AT 25.26 FEET ( THE EASTERLY RIGHT OF WAY LINE OF "COUNTRY WOOD DRIVE" ) AND 80.30 FEET.

THE BEARINGS IN THE ABOVE DESCRIPTION ARE BASED ON THE EAST LINE OF SECTION #8 AS BEING S 3° 11' 17" W *ie.* ALL BEARINGS DESCRIBED HEREIN ARE TO AN ASSUMED MERIDIAN AND ARE USED TO DENOTE ANGLES ONLY.




