BEING A PART OF THE EAST HALF OF SECTION # 8, TOWNSHIP 16 NORTH, RANGE 14 WEST, CONGRESS LANDS, SPRINGFIELD TOWNSHIP, MUSKINGUM COUNTY, OHIO [ALSO BEING A PART OF DOGWOOD ESTATES SUBDIVISION OF PLAT BOOK 18, PAGE 85 AND A PART OF THE PROPERTY OF MAYSVILLE DEVELOPMENT LTD OF OFFICIAL RECORD BOOK 1674, PAGE 558 OF THE MUSKINGUM COUNTY RECORDER] AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

[THE FOLLOWING 2.17 ACRES PARCEL TO BE DESCRIBED IS BOUNDED ON THE NORTH BY THE AFORESAID "MAYSVILLE DEVELOPMENT LTD." PROPERTY, BOUNDED ON THE EAST BY THE PROPERTY OF FRED C. and LINDA L. POLK OF DEED BOOK 762, PAGE 73, BOUNDED ON THE SOUTH BY THE PROPERTY OF ELIZABETH A. BURTON OF OFFICIAL RECORD BOOK 1873, PAGE 342 AND IS BOUNDED ON THE WEST BY THE PROPERTIES OF DAVID B. and VICTORIA M. THOMAS OF OFFICIAL RECORD BOOK 1879, PAGE 736 AND BY JASON A. and JULIE L. LEE OF OFFICIAL RECORD BOOK 1903, PAGE 888, ALL OF THE MUSKINGUM COUNTY RECORDER]

BEGINNING AT AN EXISTING IRON PIN MARKING THE SOUTHEAST CORNER OF LOT #3 IN SAID "DOGWOOD ESTATES SUBDIVISION";

THENCE S 78° 17' 40" W 580.92 FEET, IN THE NORTH BOUNDARY OF SAID "BURTON" PROPERTY AND IN THE NORTH LINE OF LOT # 4 IN SAID "DOGWOOD ESTATES SUBDIVISION", TO A POINT IN THE CENTERLINE OF, 50.00 FEET WIDE, COUNTRY WOOD DRIVE MARKING THE SOUTHWEST CORNER OF LOT #3, PASSING EXISTING IRON PINS AT 425.79 FEET, 527.68 FEET AND 555.41 FEET [THE EASTERLY RIGHT OF WAY LINE OF "COUNTRY WOOD DRIVE"]

THENCE, LEAVING SAID "BURTON" PROPERTY, N 23° 12' 00" W 241.67 FEET, IN THE CENTERLINE OF "COUNTRY WOOD DRIVE" AND IN THE AFORESAID "THOMAS" BOUNDARY AND THE AFORESAID "LEE" BOUNDARY, TO A POINT;

THENCE, LEAVING "COUNTRY WOOD DRIVE" AND SAID "LEE" PROPERTY, N 85° 58' 00" E 303.71 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET IN THE EASTERLY RIGHT OF WAY LINE OF "COUNTRY WOOD DRIVE" AT 26.47 FEET;

THENCE S 73° 00' 00" E 378.46 FEET TO AN IRON PIN SET IN THE EAST LINE OF SECTION #8, IN THE EAST LINE OF LOT # 3 AND IN SAID "POLK", WEST, BOUNDARY;

THENCE S 3° 11' 17" W 15.00 FEET, IN THE EAST LINE OF SECTION #8 AND IN SAID "POLK" BOUNDARY, TO AN "EXISTING IRON PIN" MARKING THE SOUTHEAST CORNER OF "LOT #3" AND THE "PLACE OF BEGINNING" OF THIS 2.17 ACRE PARCEL.

THE PARCEL AS DESCRIBED CONTAINS 2.17 ACRES, MORE OR LESS, SUBJECT TO ALL LEGAL HIGHWAYS AND EASEMENTS OF RECORD.

THE BEARINGS IN THE ABOVE DESCRIPTION ARE BASED ON THE EAST LINE OF SECTION #8 AS BEING S 3° 11' 17" W ie. ALL BEARINGS DESCRIBED HEREIN ARE TO AN ASSUMED MERIDIAN AND ARE USED TO DENOTE ANGLES ONLY.


Special Note:


