LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Springfield, and being part of the southwest quarter of Section 8, Township 16, Range 14, and being part of those lands intended to be described in Deed Volume 725, page 137; being further bounded and described as follows:

Commencing at the northwest corner of the southwest quarter of said Section 8, thence, South 00 degrees – 56 minutes – 35 seconds West, 691.84 feet to a railroad spike found; thence, South 89 degrees – 30 minutes – 31 seconds East, 1600.02 feet to an iron pin found; thence, South 00 degrees – 00 minutes – 00 seconds West, 599.52 feet to an iron pin found; thence, North 90 degrees – 00 minutes – 00 seconds West, 110.00 feet to an iron pin found; thence, South 00 degrees – 00 minutes – 00 seconds West, 79.06 feet to an iron pin set, and the **true point of beginning** for the parcel herein intended to be described;

Thence, North 70 degrees – 43 minutes – 28 seconds East, 118.59 feet to an iron pin set;

Thence, South 02 degrees – 58 minutes – 29 seconds East, 666.35 feet to a point in Coopermill Road, passing an iron pin set at 646.35 feet;

Thence, along said Coopermill Road, the following two (2) courses and distances:

- 1) South 71 degrees – 42 minutes – 21 seconds West, 116.12 feet to a point;
- 2) South 67 degrees – 48 minutes – 31 seconds West, 39.17 feet to a railroad spike found;

Thence, leaving said road, North 00 degrees – 00 minutes – 00 seconds East, 677.55 feet to the **point of beginning**, and containing 2.007 acres more or less.



