

DESCRIPTION OF SURVEY FOR CHRIS GRAY

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of Lot #5 of the Pinkerton Road Subdivision, recorded in Plat File 1, Number 108 & 108-B, further being part of the Chris Gray property described in deed reference Deed Book Volume 1154, Page 72 of said county's deed records, known as Muskingum County Auditor's Parcel Number 62-22-01-45-000, and more particularly described as follows;

Beginning at the Northern corner of said Lot #5, also being the Western corner for Lot #4 of said Pinkerton Road Subdivision, located in the center of Pinkerton Road (Township Road #422);

- #1- thence S 53 47 30 E 613.88 feet leaving said road and along the common line for said Lots #4 & #5 to an iron pin (set), passing an iron pin (found) at 24.99 feet;
- #2- thence S 36 12 30 W 286.68 feet through said Lot #5 to an iron pin (set) on the common line for said Lot #5 and for Lot #6 of said Pinkerton Road Subdivision;
- #3- thence N 53 47 30 W 601.69 feet along the common line for said Lots #5 & #6 to the Western corner of said Lot #5, Northern corner of said Lot #6, center line of said Pinkerton Road, and common line for said Pinkerton Road Subdivision and the T & K Stemm property recorded in deed reference Deed Book Volume 1152, Page 213, passing an iron pin (found) at 579.37 feet;
- #4- thence N 33 46 20 E 286.94 feet along the center of said Pinkerton Road and common line for said Pinkerton Road Subdivision and Stemm property to the place of beginning, containing 4.00 acres.






